# **Budget**

#### **Implementation**

The Ogden Avenue Corridor Improvements Project is currently in the preliminary engineering design process. Safe Streets and Roads for All (SS4A) implementation funds are requested for the construction stage of this project based on preliminary cost estimates. All items included in these estimates are listed in the table below. Although the final scope of the project will include streetscaping, landscaping, and placemaking improvements, those costs which are not expected to have a direct safety impact are not included in the estimate below, and SS4A funding is not requested for those enhancements. The estimated total cost for construction of eligible safety improvements is \$30,250,000. 20% of this cost (\$6,050,000) will be funded locally, and we are requesting 80% Federal funding (\$24,200,000) through SS4A.

Five of six census tracts containing the Ogden Avenue Corridor Improvements Project are USDOT Disadvantaged Census Tracts. 63% of the project is within these tracts, representing \$19,057,500 in construction costs and \$15,246,000 in requested Federal funds for implementation.

### **Supplemental Planning**

Supplemental planning funding is requested to update Chicago's Vision Zero action plan city-wide at an estimated total cost of \$1,000,000. 20% of this cost (\$200,000) will be funded locally, and 80% funding (\$800,000) is requested through SS4A.

The city-wide Vision Zero plan update will benefit all residents. 53% of Chicagoans live in disadvantaged census tracts, so we anticipate \$530,000 of the \$1 Million total supplemental planning cost will benefit underserved communities. This includes \$424,000 in requested Federal funds.

## **Budget Totals**

Total spending for the combined implementation and supplemental planning portions of this application is estimated at \$31,250,000. \$19,587,500 of this cost will benefit underserved communities, including \$15,670,000 in requested SS4A funding.
