I am writing to express my support for the City of Chicago's application for Safe Streets and Roads for All (SS4A) funding for the INVEST South/West North Lawndale: Ogden Avenue Corridor Improvements Project. This project will turn a wide corridor with excess vehicular capacity into a safer, slower, more welcoming environment for all modes of travel.

The North Lawndale community was identified as a High Crash Area through the City of Chicago's original Vision Zero Chicago Action Plan. In the more recent Vision Zero West Side Plan, community members identified Ogden Avenue as a focus corridor for improved pedestrian and bicycle infrastructure. The INVEST South/West North Lawndale: Ogden Avenue Corridor Improvements project implements many of the strategies developed in the action plan to dramatically reduce fatalities and serious injuries. Preliminary safety improvements have been identified based on previous community input, crash analysis, and initial feasibility studies. Ongoing community involvement continues to inform the designs for this project as they are refined and finalized. Frontage roads along Ogden Avenue will be reconfigured to limit or close access at intersections, and one travel lane in each direction will be eliminated. These measures will reduce conflict points, shorten crossing distances, and slow traffic while creating space for new separate bicycle facilities. Additional improvements such as pedestrian refuge medians, curb extensions, raised crosswalks, and signal improvements will further increase safety for all roadway users.

Beyond its safety benefits, this project will re-activate the neighborhood core of a community designated as a Historically Disadvantaged and an Area of Persistent Poverty. Ogden Avenue serves as a critical connector for residents to access transit and major commercial areas, schools, hospitals, and parks. North Lawndale is a priority area for the City's INVEST South/West initiative, which aims to reduce decades of disinvestment. The safety improvements proposed for Ogden Avenue will contribute to the overall INVEST South/West goals of improving quality of life, increasing access to employment opportunities, and boosting economic development initiatives.
